ARTICLE I

NAME

The name of this corporation shall be Get Gorgeous, Inc.

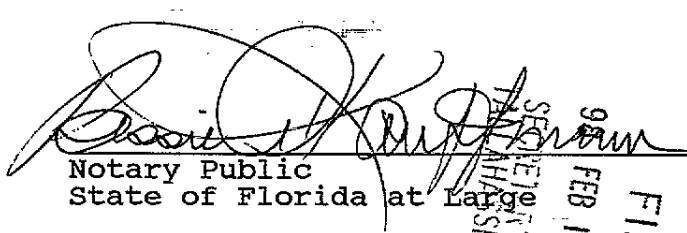
