WE, THE UNDERSIGNED, do hereby associate myself together for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

#### ARTICLE 1 - NAME

The name of the Corporation shall be:

Aroward Select Truck Sales, Inc., a Florida Corporation

#### **ARTICLE 11 - PURPOSE**

A. To carry on and engage in the purchase, sale, distribution, lease, and to otherwise deal in the wholesale and retail sale and purchase of all types of used motor vehicles, including
