ARTICLES OF INCORPORATION
OF

Food Service Concepts Of America, Inc.

I, the undersigned, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: Food Service Concepts Of America, Inc.

ARTICLE II

This corporation is organized to market, promote, provide, and/or manage miscellaneous food service systems and operations in all types of businesses and/or other entities. The corporation may also conduct other related enterprises not prohibited by law.

ARTICLE III

ARTICLE IX




