ARTICLES OF INCORPORATION OF J.C. REIGNS, INC.

PREAMBLE

The undersigned, do hereby associate myself under the following Articles, for the purpose of forming a Corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation shall be:

ARTICLE II
