ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Insorporation, a natural person, competent to contract, hereby comes to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 et. seq., and the corporation so formed shall be for profit.

ARTICLE I - NAME, OFFICE & MAILING ADDRESS

ARTICLE II - TERM OF EXISTENCE

This corporation is to exist perpetually and shall commence February 14, 1998.

The general nature of the business to be transacted by this corporation shall be to create and syndicate greeting cards and other Vivian Greene creations, within and without the United States; as well as any other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business.
