

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I --- NAME AND ADDRESS

The name of the corporation shall be PRESSURE WORKS, INC. and the address of the corporation shall be 1340 Waterway Cove Drive, Wellington, Florida 33414.

ARTICLE II -- DURATION

The corporation shall have perpetual existence.

ARTICLE III --- PURPOSE

The corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV --- CAPITAL STOCK
