NAME

The number of directors may be changed from time to time by the bylaws.

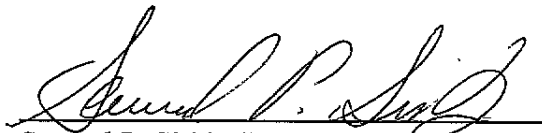

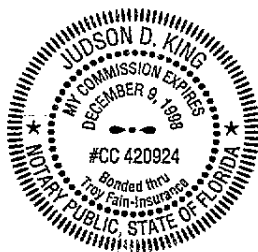

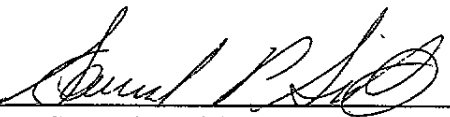
