#### ARTICLES OF INCORPORATION

## ARTICLE I - NAME

The name of this corporation is BEAVER RIDGE CONCRETE PUMPING, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
