

ARTICLES OF INCORPORATION
OF

The undersigned incorporator to these articles of incorporation hereby forms a corporation ("the Corporation") under the laws of the State of Florida as follows:

ARTICLE I
Name

The name of the Corporation is: **JAMSI CORPORATION, INC.**

ARTICLE II
Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these articles of incorporation by the office of the Florida Department of State and the Corporation shall have the perpetual existence thereafter.

ARTICLE III
Nature of Business

The corporation is organized to engage in the Convenience store business and in any and all other lawful business.

ARTICLE IV
Capital Stock

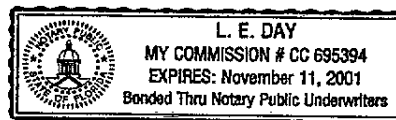





