

The undersigned subscriber to these Articles of Incorporation, Michael Marks, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is GREEN ACRES TURF FARMS, INC. The principal office and mailing address of the corporation is 3503 Pinstar Terrace, Northport, Florida 34287.
