ARTICLES OF INCORPORATION OF

Tony's Apartment and Appliance Services Inc.

The undersigned, are natural persons competant to contract, hereby, form a corporation under the laws of the State of Florida.

FIRST: The name of the corporation is Tony's Apartment and Appliance Services Inc.

SECOND: The Corporation is to rent apartments, manage apartments repair apartments , repair appliances and upkeep apartments. SIXTH: The Corporation shall have one (1) director initially. The number of directors may be changed from time to time by amendment to, or in the manner provided in, the bylaws of the Corporation.

SEVENTH: The initial director of the Corporation who shall hold office for the first year of the Corporation's existence or until their successors are elected or appointed and have

qaulified, will be Antonio Delgado, 3079 Hypoluxo Road, Lantana, Florida 33462.

EIGHTH: The name and address of the sole incorporator is Antonio Delgado, 3079 Hypoluxo Road, Lantana, Florida 33462.

NINTH: The power to adopt, alter, amend and appeal by laws shall be vested in the Board of Directors and the Shareholders.
