ARTICLE I - NAME

The name of this Corporation is P & L FINANCE, INC..

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida. The primary purpose of the corporation is to become licensed and operate as a finance company pursuant to chapter 494, Florida Statutes.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is One Thousand shares of common stock having a par value of \$.10 per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT AND PRINCIPAL

PLACE OF BUSINESS

The initial registered office and principal place of business of this Corporation shall be 1744 West Jefferson Street, Quincy, Florida 32351. The initial registered agent shall be Scott Pilkington, who upon having accepted this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.


