ARTICLES OF INCORPORATION OF DMC, INC.

The undersigned incorporator to these Articles of The Incorporation, a natural person competent to contract, hereby conganizes and incorporates a corporation under the laws of The State of Florida.

ARTICLE I. NAME

The name of the corporation is DMC, INC.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in the transaction of any or all lawful business permitted under the laws of the United States and the Florida General Corporation Act.

The date when the corporate existence of this corporation shall begin business shall be the time of the filing of these Articles of Incorporation by the Department of State.

ARTICLE VII. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VIII. INITIAL REGISTERED OFFICE AND AGENT
