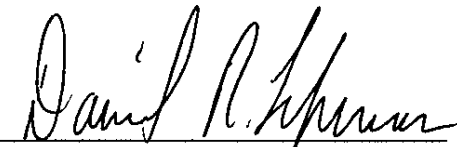

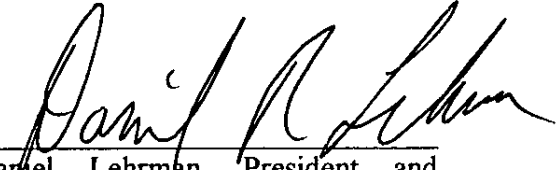

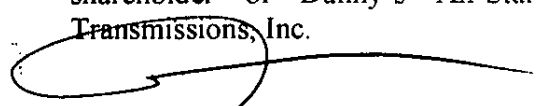
STATEMENT OF INTENT TO DISSOLVE
