ARTICLES OF INCORPORATION OF FLORIDA COMMERCIAL AND INVESTMENT BROKERS, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is FLORIDA COMMERCIAL AND INVESTMENT BROKERS, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and/or lawful business including but not limited to, Real Estate and Business Brokerage.

The aggregate number of shares which the corporation is authorized to issue is 1000 shares of common stock. Such shares shall be of a single class and have no par value.

ARTICLE X - THE RIGHT OF THE INITIAL DIRECTOR
