ARTICLES OF INCORPORATION LAMINATE FLOORING SERVICES, INC.

ARTICLE I Name

The name of this corporation is Laminate Flooring Services, Inc..

ARTICLE II Principal Office

The principal office of the corporation shall be 10285 Stonington Way Jacksonville, Florida 32221.

ARTICLE III Duration

The corporation shall have perpetual existence.

ARTICLE IV **Purposes and Powers**
