ARTICLE I - NAME:

The name of this corporation is: PARADISE DESIGNS OF  
N.W. FLORIDA, INC., hereinafter referred to as the  
"Corporation")

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the  
filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the  
Interior Design business, and for the purpose of transacting  
any or all other lawful business not inconsistent with the Laws of the  
State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One  
Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of

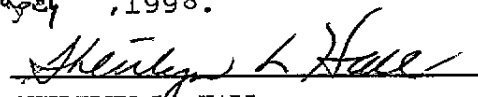
ARTICLE IX - BY-LAWS:
