## CAPITAL STOCK

This Corporation is authorized to issue par value common stock as described below, and none other:

The authorized shares of par value common stock may be issued only for a consideration having a value, in the judgment of the Board of Directors, equivalent at least, to the full par value of the stock to be issued.
