**ARTICLES OF INCORPORATION
OF
PAXSON COMMUNICATIONS OF ODESSA-30, INC.**

The undersigned, acting as incorporator of PAXSON COMMUNICATIONS OF ODESSA-30, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial director is:


ARTICLE IX. BYLAWS
