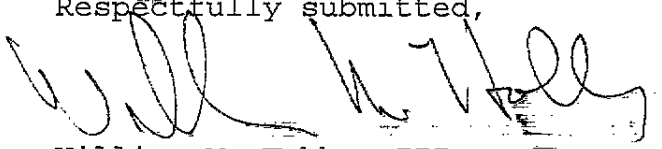

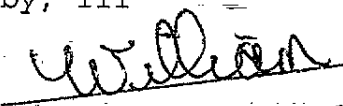

This corporation shall have perpetual existence unless dissolved according to law.

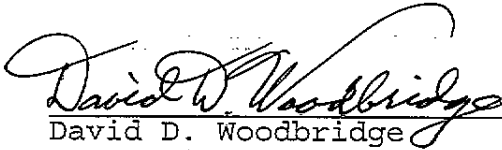
Article X - Action by Directors Without a Meeting

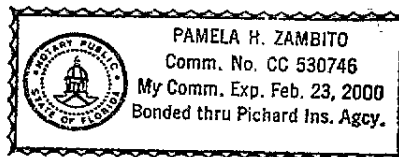

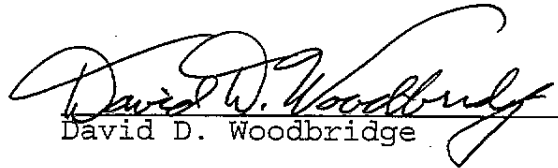
