ARTICLES OF INCORPORATION OF D-Jam, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is D-Jam, Inc. The specific nature and purpose of the corporation shall be, but shall not be limited to, the sale of jewelry and clothing accessories.
