OF

The undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Professional Service Corporation under Chapter 621 of the Florida Statutes.

ARTICLE I. NAME

The name of the corporation ("Corporation") is

ARTICLE II. TERM OF EXISTENCE

The corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.



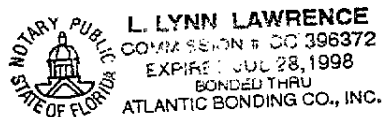


