ARTICLE ONE

The name of the corporation is COMPUTEL SYSTEMS, INC. The principal address of the corporation is: 6687 N.W. 16th Terrace, Ft. Lauderdale, Florida 33309.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is 100, at \$1.00 par value.


ARTICLE FIVE

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
