ARTICLES OF INCORPORATION



OF

ALLANASSERVISIANES The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.
