OF

The undersigned, for the purpose of forming a professional association under the laws of the State of Florida,
do hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation shall be:

ARTICLE III
NATURE OF CORPORATE BUSINESS

The Professional Association may engage in every aspect of the practice of medicine and all other purposes for which professional associations may be incorporated under the laws of the State of Florida. 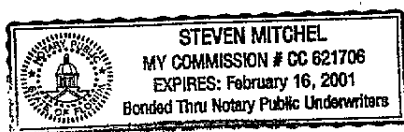
