ARTICLES OF INCORPORATION  
of

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formulation, liability, rights, privileges and immunities of a corporation for profit.

Article I: Name

The name of this Corporation shall be Anti-Crime Crusade, Inc.

Article II: Duration

This Corporation shall have perpetual existence.

Article III: Nature of Business

The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

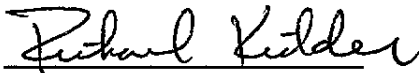



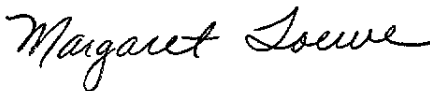
