The undersigned subscriber to these Articles of Incorporation under natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTCLE I - NAME

The name of this Corporation is SUPER SPORTS PROMOTIONS, INC.

ARTICLE II - DURATION

The existence of this Corporation is to begin at the time of subscription and acknowledgement of incorporation and to continue perpetually thereafter.

<u>ARTICLE III - PURPOSE</u>
