#### ARTICLES OF INCORPORATION

OF

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a comporation for profit under the General Corporation Act and other laws of the State of Florida.

#### ARTICLE I. NAME AND PRINCIPAL OFFICE

#### ARTICLE II. DURATION

This corporation is to exist perpetually.

#### ARTICLE III. PURPOSE
