The undersigned natural person(s), of the age of 21 or more, acting to form a corporation under the Chapter 607 Florida Corporate Code, do hereby certify the following:

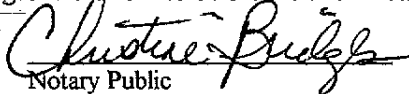
- FIRST: The name of the corporation shall be J & M Drywall, Inc.
