

ARTICLE I - NAME

The name of this corporation is Stock Options, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 10,000 shares of one (\$1.00) Dollar per value common stock, which shall be designated "Common Shares."


ARTICLE X - INCORPORATOR

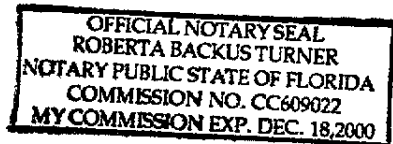
