SO FOLLOW TO THE PARTY OF THE P SUSAN A. STOTZER, the undersigned, hereby make the within Articles Incorporation for the purpose of becoming incorporated and being a corporation under and by virtue of the laws of the State of Florida under the following proposed charter:

#### ARTICLE | - NAME/ADDRESS
