**ARTICLES OF INCORPORATION
OF
INNER/G CORPORATION**

THE UNDERSIGNED, acting as sole incorporator of INNER/G CORPORATION under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is "inner/g corporation."

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

**ARTICLE III

INITIAL BOARD OF DIRECTORS**

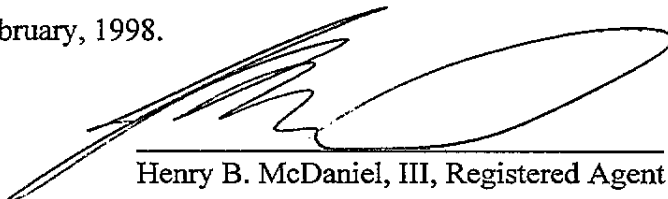
