ARTICLES OF INCORPORATION
OF
RF Data Corp.

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is RF Data Corp.

SECOND: The address, wherever located, of the principal office of the corporation is 20496 Sausalito Drive, Boca Raton, Palm Beach County, Florida 33498

THIRD: The number of shares that the corporation is authorized to issue is Seven Thousand Five Hundred (7,500) Shares, all of which are of a par value of One (\$1.00) Dollar each. All of the shares are Common Shares.

FOURTH: The street address of the initial registered agent of the corporation in the State of Florida is: 20496 Sausalito Drive, Boca Raton, Florida 33498. The name of the initial registered agent of the corporation at the said registered office is Gary M. Berke. The written acceptance of the said initial registered agent, as required in Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

FIFTH: The name and the address of the incorporator is: Gary M. Berke, 20496 Sausalito Drive, Boca Raton, FL 33498.

SIXTH: The purposes for which the corporation is organized, which shall include the authority of the corporation to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act, are as follows:

To transact any and all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act and the laws of the United States and to have all of the general powers granted to corporations organized under the Florida Business Corporation Act, whether granted by specific statutory authority or by construction of law.

SEVENTH: The duration of the corporation shall be of perpetual existence, which existence shall commence upon the date these Articles of Incorporation are filed with the Florida Secretary of State.


EIGHT: The corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporations Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to any person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

NINTH: This corporation shall have two (2) directors initially. The number of directors may either be increased or decreased or diminished from time to time by the By-Laws but shall never be less than one (1).


