I, the undersigned, being the sole Stockholder of JS LAWN CARE, INC., a Florida corporation, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted by unanimous vote of the Stockholders at a meeting duly held on the 30th day of March, 2001.

Effective March 30, 2001, the current Article SEVENTH was deleted in its entirety, and the following substituted in its place:

SEVENTH: This corporation shall have at least one Director The number of directors may be increased by Bylaws adopted by the Stockholders at any time from time to time .

John G. Sailer, Jr. is the sole director.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
