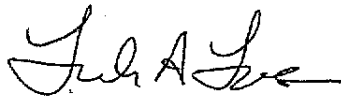

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. NAME AND PRINCIPAL OFFICE**

The name of the corporation is Royal Palm Builders III, Inc. The address of the principal office of the corporation is 5811 Pelican Bay Blvd., Suite 208, Naples, Florida 34108.

**ARTICLE II. DURATION**

The corporation shall have perpetual existence.

**ARTICLE III. PURPOSE**

The purpose of the corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

**ARTICLE IV. CAPITAL STOCK**

The corporation is authorized to issue One Thousand (1000) shares, all of one class, at \$1.00 par value.

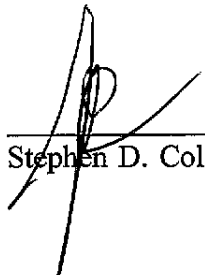
## **ARTICLE VIII. INDEMNIFICATION**

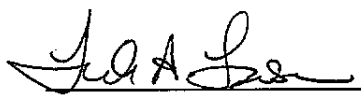
