**ARTICLE I.**

The name of this Corporation is: SEYPER CORPORATION

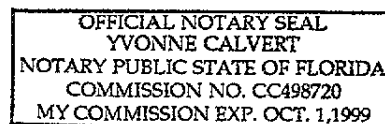
