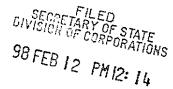

# ARTICLES OF INCORPORATION

<u>OF</u>

#### A & M CONSTRUCTION SPECIALISTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I. NAME.

The name of this Corporation shall be A & M CONSTRUCTION SPECIALISTS, INC.

#### ARTICLE II. COMMENCEMENT & DURATION.

The existence of the Corporation will commence upon filing as provided by the laws of the State of Florida, and will continue thereafter perpetually.

#### ARTICLE III. PRINCIPAL OFFICE.
