ARTICLES OF AMENDMENT (1) CONTROL OF ARTICLES OF INCORPORATION (2) CONTROL OF OGS INVESTMENTS, INC.

Pursuant to the provisions of Section 607.1006, *Florida Statutes*, OGS Investments, Inc. ("Corporation") adopts the following Articles of Amendment to the Articles of Incorporation.

Amendment adopted: Article VIII, Section 1, of the Corporation's Articles of Incorporation is hereby amended to read as follows:

ARTICLE VIII - NUMBER OF DIRECTORS

Section 1 - Number of Directors: The Board of Directors of the Corporation shall be comprised of not less than (5) nor more than (25) directors and shall be fixed from time to time exclusively by the Board of Directors pursuant to a resolution adopted by a majority of the Full Board as set forth in the Corporation's Bylaws. The Board of Directors is authorized to increase the number of directors by no more than two and to immediately appoint persons to fill the new director positions until the next Annual Meeting of Shareholders, at which meeting the new director positions shall be filled by persons elected by the shareholders of the Corporation. However, this Section shall not be construed to limit the authority of the shareholders of the Corporation to increase the number of directors in accordance with the Bylaws of the Corporation.

The above amendment was approved by the Shareholders of the Corporation at a Special Meeting of Shareholders held on June 18, 1998. In accordance with Section 607.1003, *Florida Statutes*, each shareholder received a copy of the proposed amendment and was notified of the date and purpose of the Special Meeting at which the amendment was considered. The amendment shall become effective on July 9, 1998.
