ARTICLES OF INCORPORATION TEMPUS MARKETING INTERNATIONAL, INC.

PORTO 13 PM 3:00 The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be TEMPUS MARKETING INTERNATIONAL, INC.

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by the Florida Business Corporation Act.


