ARTICLES OF INCORPORATION

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Unicorp National Developments, Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 7680 Republic Drive, Suite 110, Orlando, Florida 32819, and its mailing address is Post Office Box 1879, Windermere, Florida 34786-1879.

ARTICLE III

Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

Duration of the Corporation




