ARTICLES OF INCORPORATION

OF

ECK-WINTER PARK 2, INC.



The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Eck-Winter Park 2, Inc.

ARTICLE II

Principal Office
