The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

EFFECTIVE DATE

02-12-98

Corporate Name and Address

The name of the Corporation is Rocky Cat, Inc., and the address of the principal office and mailing address of the Corporation is 6583 Plantation Pines, Fort Myers, Florida 33912.

ARTICLE II

Corporate Purpose
