ARTICLES OF INCORPORATION
OF
MCMAHAN RESEARCH LABORATORIES, INC.

The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be MCMAHAN RESEARCH LABORATORIES, INC. and the business address and location of the Corporation shall be 2160 Park Avenue North, Winter Park, Florida 32789.

CORPORATE DURATION
