Articles of Incorporation were filed on February 13, 1998, showing the mailing address as "1300 Thomaswood Drive, Tallahassee, Florida 32312" and showing the registered agent's address as "1300 Thomaswood Drive, Tallahassee, Florida 32312" (see attached Exhibit "A"). Also attached as Exhibit "B", is a copy of a Corporate Detail Record from the Secretary of State. As you can see on the Detail Record, the address is incorrectly listed as "1300 Thomaswille Drive, Tallahassee, Florida 32312". There is no Thomaswille Drive in Tallahassee. Unfortunately the Annual Report form must have been sent by the Division to the wrong (nonexistent) address.

This corporation was administratively dissolved this fall for failing to file its Annual Report. We are in the process of reinstating the corporation and intend to tender the full amount assessed by the Division necessary for reinstatement. However, we do not believe that the penalty should be paid, since the mistake was made by the Division and not our client. As such we request that the Division waive the penalty of \$600.00 and the Supplemental Fee of \$88.75, and allow our client to be reinstated by payment of the \$61.25 annual fee.
