The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, does hereby associate and adopt the following Articles of Incorporation for such corporation:

I. **NAME**: The name of the corporation shall be **FLORIDA FIBRE RECYCLING, INC.**, and it is to be located at 14063 Bruni Drive, Spring Hill, Hernando County, Florida 34609.

II. **BUSINESS PURPOSE**: The nature and purpose of the corporation will be to own and operate a broker and packer of waste paper recycling and all other activities associated with the business. 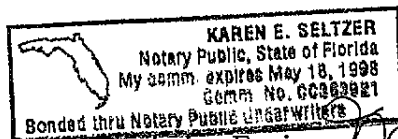


