Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of LandMark Financial Holding Company are hereby amended as follows:

<u>FIRST</u>: The first sentence of Section A of Article 3 is hereby amended by deleting such sentence in its entirety, and inserting the following in lieu thereof.

The total number of shares of all classes of capital stock which the Corporation shall have the authority to issue is 21,000,000, consisting of 20,000,000 shares of common stock, par value \$0.01 per share (the "Common Stock") and 1,000,000 shares of preferred stock, par value \$0.01 per share (the "Preferred Stock").

SECOND: The foregoing amendment was adopted by the holders of all the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on April 21, 2010 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
