Articles of Incorporation

TIRES 2 U OF FLORIDA, INC. a Florida corporation

WE, THE UNDERSIGNED, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as, follows:

ARTICLE 1 - NAME

The name of the Corporation shall be:

TIRES 2 U OF FLORIDA, INC.

A FLORIDA CORPORATION

ARTICLE 11 - PURPOSE

- A. To carry on and engage in the purchase, sale, distribution, lease, and to otherwise deal in the wholesale and retail sale, purchase, and installation of all types of automobile, motorcycle, and truck tires and all accessories and parts related thereto; and to do all other acts which may be necessary or related thereto.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

ARTICLE 111 - CAPITAL STOCK

The Corporation shall be authorized to issue capital stock in the following manner, to wit:

ONE THOUSAND (1,000) Shares of Common Stock, having no par value.

ARTICLE IV - POWERS

The powers of the Corporation shall include all those conferred by the bylaws of the Corporation and the laws of the State of Florida.

ARTICLE V - TERM OF EXISTENCE

The Corporation shall have perpetual existence, in accordance with the laws of the State of Florida.

ARTICLE VI - PRINCIPAL PLACE OF BUSINESS

The principal place of business of the Corporation shall be:

ARTICLE VII - REGISTERED AGENT AND OFFICE


