**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
AUTO EUROPA, INC.**

The undersigned, Martin R. Kaczmarek, being the duly elected President of Auto Europa, Inc., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation (the "Articles") were filed with the Secretary of State of the State of Florida on February 16, 1998 under Document Number P98000014977.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows, which Amended and Restated Articles of Incorporation incorporate amendments to all articles of the Articles of Corporation:

ARTICLE I - NAME

The name of this corporation is Auto Europa, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE X - AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

Such amendments to, and amendment and restatement of, the Articles of the Corporation have been duly and unanimously authorized and directed by Written Consent of the Board of Directors and shareholders of the Corporation dated November 20, 2007. Such amendment and restatement of the Articles of the Corporation supersedes the original Articles of the Corporation in their entirety.
