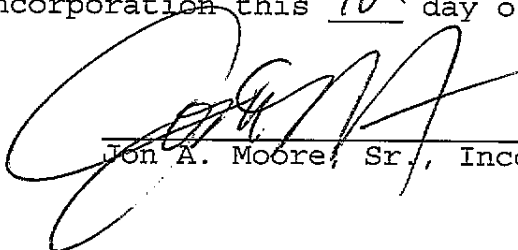
ARTICLE V. INCORPORATOR

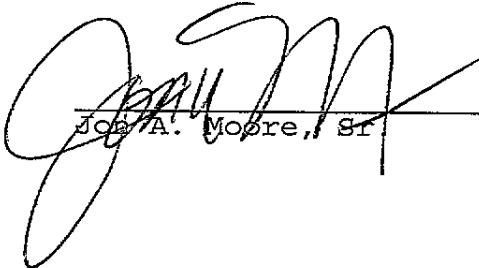

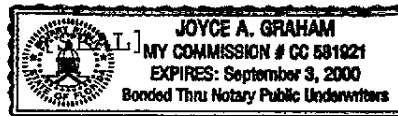
