### ARTICLES OF INCORPORATION OF OFFSHORE TECHNOLOGY TRADERS CORP.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation shall be **OFFSHORE TECHNOLOGY TRADERS CORP.** 

#### ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 18052 S.W. 33rd Street, Miramar, Florida 33029. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

#### ARTICLE III. PURPOSE

The general nature of the business to be transacted by the corporation shall include any or all lawful business with all powers conferred upon Corporations by the Laws of the State of Florida. The number of shares of stock that this corporation is authorized to have outstanding at any one time is one-hundred (100) shares of One (\$1.00) Dollar par value. Initially, same shall be distributed 100% to Eleonora Ramos.
